On June 17, 1917 at the invitation of Melvin Jones, delegates met in Chicago. The only point of contention was the selection of a name for the new organization. Melvin Jones researched the idea of calling the new organization Lions. He was convinced that the lion stood for strength, courage, fidelity and vital action. On a secret ballot the name Lions was chosen over several others.

# **13 OH6 District Governor's 2020-21 Goals**

1. Each club host a prospective member meeting by inviting people to attend. Club provide overview of Lions and show videos/photos of activities. Establish and maintain communication. Utilize Ohio Plan. Mentor new members and make them a real part of the club. Retain current members by keeping involved in club and activities. Also, implement the use of the North American Membership Initiative (NAMI).
2. Charter one new club and be a plus 8 in members for OH6 by June 30, 2021.
3. Utilize My Lion to report activities. Lions being able to show all the hours that Lions dedicate is impressive and could help with member recruitment. Also, being able to show all the different kinds of things that Lions do can get the interest up for potential members.
4. Conduct training on electronic use of programs such as Zoom to allow hosting of meetings when they cannot be done in person. Utilize Zoom or other electronic means to conduct Lions business and communicate with membership.
5. Continue to expand the OH6 team for pediatric cancer research. Expand role for STEPS Walk/Run across the District. Define roles/responsibilities. Establish larger audience via advertisements/sponsorships of Lions Clubs. Clubs sponsor runners/walkers. All clubs participate via help at the event, financial support, staff, be runners/walkers.
6. Increase LCIF district club contributions by 5%.
7. The district will attain 28% female membership by June 30, 2021.

- **Whenever** a doubt arises as to the right or ethics of my position or action towards others, to resolve such doubt against myself.
- **To Hold** friendship as an end and not a means. To hold that true friendship exists not on account of the service performed by one another, but that true friendship demands nothing but accepts service in the spirit in which it is given.
- **Always** to bear in mind my obligations as a citizen to my nation, my state, and my community, as to give them my unswerving loyalty in word, act, and deed. To give them freely of my time, labor and means.
